Schultz, entered a plea of guilty to the offense of felony theft (Ill.Rev. Stat.1989, ch. 38, par. 16-1(a)(1)(A)). The trial court initially sentenced defendant to two years probation, but subsequently set aside the probation and sentenced defendant to six months' probation and six months' periodic imprisonment. The periodic imprisonment term required defendant to perform 100 hours of community service and to pay \$1,000 toward his fine. The trial court directed that, upon completion of the period of periodic imprisonment, defendant would be given credit for the six months of service against the one year period of supervised release to which defendant had agreed to serve. While on probation defendant was charged with the offense of burglary and subsequently pleaded guilty. Defendant argued at the time of his sentencing for the theft offense
